


On 20 January 2004, by the side of the Nile River, CRCICA celebrated its 25th anniversary. The Celebration was attended by various key figures from Egypt, some Arab countries and international institutions. That is why the period 2004/2005 is a highly significant chronological mark in the history of the Cairo Centre as it witnesses its 25th anniversary and the momentous turn to a new era of progress with a fresh vision of a highly promising future. The present report is meant to shed light on the Cairo Centre's achievements during 2004/2005 in case administration, organization of events, external relations and other activities.


CASE REPORT

The total number of arbitration cases filed before CRCICA reaches 441 cases, 56 of which were filed in 2004 and 15 in early 2005. As shown in the following chart, 2003 and 2004 keep almost the same line of increase in case referrals, scoring a stable 35% increase in referrals as compared to arbitrations commenced in 2002.





As shown below, construction arbitrations constitute more than 37% of 2004 referrals followed by service arbitrations (32%). According to the right-hand-side chart, in the early months of 2005, concession agreements share the pinnacle with construction contracts. Other contracts relate to rental, management, sale, operation, partnership, employment, supply and agency.





In 2004/2005, beside multinational corporations, parties to CRCICA arbitration proceedings are business entities from a broad span of countries, including Saudi Arabia, the United Arab Emirates, Iraq, France, the Untied Kingdom, Switzerland, Spain, Italy, America and Romania (see the illustrating charts below). This variety in parties' nationalities is normally correlated by a similar variety in arbitrators'.





Beside arbitration, CRCICA administers other alternative dispute resolution techniques (ADRs). In this concern, it was invited in 2004 to host the proceedings of a Dispute Resolution Board reviewing a construction dispute between an Egyptian Company and another American one in the field of telecommunications according to a FIDIC Contract.

Moreover, in 2004/2005, the Cairo Centre continues to host non-CRCICA arbitrations. While ICC cases remain the most outstanding, for the first time, CRCICA will host an ICSID hearing in September 2005 utilizing the Cairo Centre's video-conferencing facility which is just being launched. This comes in implementation of the Cooperation Agreement concluded between CRCICA and ICSID as early as 1980¹. Similarly,

CRCICA arbitrations are held in different countries around the world such as France and Italy.

CRCICA Inaugurates its Port Said Branch

In intensification of its institutional responsiveness to arising ADR needs in different trade and investment sectors, CRCICA has been working out a geographical expansion scheme which resulted in the establishment of four Branches, the lately-inaugurated of which is the Port Said Branch². On 17 February 2004, CRCICA entered into an agreement with the Suez Canal Authority³ to establish the Port Said Branch for International Commercial and Maritime Arbitration as a Branch of the Cairo Centre. Headed by the Chairman of the Suez Canal Authority, the Board of Directors of the Branch has many key representatives of navigation companies, authorities and chambers in Port Said, Suez, Damietta and the Red Sea cities.

CRCICA EVENTS (2004/2005)

CRCICA Calendar of Events features some various interesting aspects that stand as clear tokens of an increasingly flourishing international status. *In particular, the 2004/2005 Calendar strikes a very sound variation in place, substance and form.* Moving among Egypt, Morocco, Saudi Arabia and Italy, CRCICA Events of the period under reporting have approached arbitration per se and as related to construction and investment and have intensively tackled timely issues of international trade and investment such as e-commerce, Euro-Arab Partnership Agreements, WTO Agreements and the UN Convention on Contracts for the International Sale of Goods.

³ The Suez Canal is 193 KM long and many thousands of ships pass annually through this Canal making it the busiest Canal in the world. In 2003, the Suez Canal generated \$ 2.57 billion in revenues – the highest in the Canal's 135-year history – as 15,634 ships transited the waterway with a combined cargo of around 548 millions tons.

Types of CRCICA Events in 2004/2005: (1)Serialized Conferences and relevant variation

While CRCICA mostly keeps the usual structure of its serialized events4 which are being held in 2004/2005, it plans to give a broad and renovating bend to the next Judicial Colloquium which ranks the fourth in the series of similar Colloquia held since 2000 and originally meant to depict the comparative views of arbitrators and judges of the region compared to an international background notably the UNCITRAL rules and regulations. In 2005, the Event will be patterned along an extensive and multi-cultural structure by the participation of key representatives of leading international arbitral institutions and chief justices of high courts in different countries. Within the bounds of this, key representatives of the French, English and Swiss judicial systems will contribute to the Event. Beside various Arab arbitral institutions, the so far confirmed international ones are the Arbitration Court of the International Chamber of Commerce (ICC); the American Arbitration Association which will be represented by its President Mr. William Slate; the Swiss Arbitration Association (SAA) to be represented by its President Prof. Kaufmann-Kohler; the Spanish Court of Arbitration and the Global Centre for Dispute Resolution Research which will be represented by Prof. Bernardo Cremades in his dual capacity as the Chairman of both of them; the International Federation of Commercial Arbitration Institutions (IFCAI) and the Arbitration Institute of the Stockholm Chamber of Commerce to be represented by Mr. Ulf Franke in his capacity as President of the former and Secretary-General of the latter. Other confirmations are shortly expected.

Beside keeping the tradition of holding international serialized conferences, the pattern of recent events shaped a more integrated status of CRCICA as a regional organizer of regular and commemorative

Bilaterai Events conferences of international arbitration and trade organizations. Within the bounds of this, CRCICA co-organized the first ICC/FIDIC Cairo Conference held on International Construction Contracts and Dispute Resolution on 9-10 April 2005. The most future outstanding examples of this category are the WTO Regional Conference scheduled for February 2006. In commemoration of the Tenth Anniversary of the WTO and its Appellate Body , the WTO approached CRCICA to organize a key regional conference in a series of regional conferences the Organization has been holding in different parts of the world in 2005 and 2006 under the broad title: "The WTO at 10". The total number of conferences in the series will not be more than seven and the Cairo Event features the only one of its kind in the whole African and Arab region. Along the same lines, the United Nations Commission on International Trade Law (UNCITRAL) chose CRCICA to host and organize two significant regional conferences planned to be held in September 2005 on the occasion of the 25th anniversary of the UN Convention on Contracts for the International Sale of Goods and the 20th anniversary of the UNCITRAL Model Law on International Commercial Arbitration. Similarly, CRCICA will organize the Fourth Annual UN Forum on Online Dispute Resolution, the third of which was held in Australia on the 5th and 6th of July 2004.

Bilateral events are also an important mark of the 2004/2005 Calendar; in the light of the unique Cooperation Agreement between CRCICA and the Chamber of National and International Arbitration of Milan (CAM)₅, the two parties to the Agreement held three important promotional seminars in

Cairo and Milan about International Commercial Arbitration. CRCICA and CAM plan to hold a joint arbitration training program in Egypt in 2005.

Types of CRCICA Events in 2004/2005: (3) Bilateral Events...

Jointly with CRCICA, Queen Mary School of International Arbitration (SIA) / University of London held its first Overseas Certificate Arbitration Course on 16-22 April 2005 in Cairo/Egypt. Held in Cooperation with the Cairo Branch of the Chartered Institute of Arbitrators and the American University in Cairo, the Course provided a comprehensive comparative approach with different cultural backgrounds of key arbitration experts from all around the world. Significantly enough, this magnificent variation in the backgrounds of speakers was matched by a multi-national range of respectful participants from Saudi Arabia, Jordan, Palestine, India and Egypt.

At the end of the Course, SIA and CRICICA concluded an agreement authorizing CRCICA to hold SIA International Commercial Arbitration (and other ADRs) Certificate Courses in the Afro-Asian region on regular basis. By dint of this assignment, CRCICA, will inter alia, examine the educational needs in the region and provide advice as to the adaptation of the courses to regional cultures and expectations; recommend potential speakers for approval by SIA. SIA and CRCICA will cooperate in developing a list of approved tutors including key regional lecturers who are apt to take part in the courses and will coordinate together in bringing about a unique cross-cultural dialogue.

In general, CRCICA 2004/early 2005 Conferences were attended by participants from many countries such as Egypt, Sudan, Lybia, Saudi Arabia, Kuwait, Lebanon, Syria, Jordan, Yemen, Qatar, Oman, United Arab Emirates, Palestine, Bahrain, Tunisia, Morocco, India and Pakistan

• CRCICA International Profile in 2004 and Beyond

The period under reporting has witnessed CRCICA's intensive contribution to the world of arbitration at large⁶. Within the bounds of this, it continues to review draft arbitration laws in the region, the last of which was the Moroccan Draft Law. CRCICA took part in global research activities including the ILA Research on Res Judicata and the Global Centre's on "Critical Factors in the Establishment of a Viable Arbitration Regime".

In 2004/2005, CRCICA had various significant inputs in bridging lingual gaps among users of international arbitration. In this concern, the Cairo Centre translated the Arbitration Rules of the Swiss Arbitration Association (the Swiss Rules) and the Chamber of National and International Arbitration of Milan. Similarly, CRCICA staff translated the first Arabic version of the International Trade Centre ITC's Publication entitled: "Arbitration and Alternative Dispute Resolution – how to settle international business disputes." The Cairo Centre was granted exclusive right to distribute the Publication in all Arab Countries and Arab-speaking countries of North Africa and the Middle East. On a wider scale, the UNCITRAL has recently requested CRCICA to recommend legal-lingual experts to train the Commission staff in the unification of trade law terminology. It is worth noting that the Cairo Centre's recommendations were accepted.

In the given period, CRCICA has succeeded in developing unmatched international relations with key entities involved in the developmental ADR activities all around the world such as the International Federation of

Commercial Arbitration Institutions (IFCAI), the Global Centre for Dispute Resolution Research and the International Trade Centre (ITC) (See Appen. 3)

- CRCICA launches its video-conferencing facility to be the first arbitral institution in the region offering such a high-tech sort of services.
- o CRCICA assisted the Central Bank of Egypt in laying down an integrated mechanism for the rapid settlement of Banking disputes. This includes drafting the Arbitration Rules and furnishing the Central Bank with CRCICA List of Banking arbitrators and experts.
- In 2004/2005, CRCICA offered three different individual training programs one for a Lawyer of the Palestinian Arbitration Centre (Tahkeem); another for an intern of the Georgetown University and the last for a Dutch Lawyer specialized in Online Dispute Resolution.
- CRCICA will soon sign two new cooperation agreements; one
 with the Belgian Center for Arbitration and Mediation (CEPANI)
 and the other with the Arbitration Court attached to the Economic
 Chamber of the Czech Republic and the Agricultural Chamber of
 the Czech Republic (ACCR)
- As of January 2005, CRCICA Director has taken over his responsibilities as an elected member of the Board of Trustees of the Chartered Institute of Arbitrators (London) for the Middle East / Indian Sub-Continent Region. In his new capacity, he

will work with the chairmen of the CIArb Branches in the area to design regionally-adapted CIArb Training Programs.

O Dean John B. Attanasio, Dean of SMU Dedman School of Law (Texas, U.S.A.) will visit Egypt on June 18 to present the Distinguished Global Alumnus Award to Dr. Mohamed Aboul-Enein, the Director of the Centre for his "extraordinary achievements and services that bring the Dedman School of Law outstanding positive recognition". CRCICA will invite key legal figures and justices to a welcoming reception in honor of Dean Attanasio.
